2 External auditor report 2018/19

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Section 2, Box 10 is inconsistent with the balance published
by the Public Works Loan Board. The figure in Box 10 should read £9,000. Please ensure amendments are corrected in the prior year
comparatives when completing next year's AGAR.
