## **RESTRICTIVE COVENANTS IN VIGO**

Thank you to everyone who completed the Covenant Survey enclosed with the last edition of this newsletter. We were pleased to receive over 329 responses, which represents over 40% of households. As a result of the responses, formal proposals were put to the Parish Council, with regard to how covenants are enforced in the future. Full details of the responses and proposals can be found at the bottom of this newsletter.

ON THE SUBJECT OF COVENANTS ~ We are being contacted by an increasing number of residents whose property sales are being held up due to solicitors discovering that alterations have been carried out to a property without the necessary approvals. Retrospective applications can be made, but carry a fee, and there is always a chance that the Parish Council may not be able to give approval. Always apply in advance of carrying out any work (approval needed for ALL changes to the external appearance of your property). Thank you.

# WILDLIFE CORRIDORS – What do you think?



We have been contacted by some residents to ask if we would consider reducing the frequency of grass cutting in certain areas, to allow wildflowers to flourish and provide a boost for Bees and insects that rely on such flowers. Other Councils are considering this, and some have done this.

We are not proposing to reduce our grass cutting frequency around the whole village, but are looking for areas where this might be a practical and sensible solution.

Do you have any strong thoughts on this? Would you like to nominate an area for consideration? We are going to post an online poll in the New Year, to gauge opinion so a decision can be made by Parish Council before the Spring.

#### **HEDGEHOG HIGHWAYS**

Did you know that estimated Hedgehog numbers are already down 95% since the 1950s. In view of this drastic decline in the hedgehog population people are being encouraged by the Government, the Hedgehog Preservation Society and other bodies, to create Hedgehog Highways in their garden boundary fencing.

British gardens are becoming poorer homes for wildlife with increased paving, decking and reduced plant life. We are seeing a huge loss in connectivity between green spaces leaving hedgehogs isolated as properties have boundaries impenetrable to hedgehogs.



Hedgehog Highways are created by making space for hedgehogs to roam allowing them to seek food and habitat. A 13cm hole in the base of a fence allowing gardens to be connected, creating the pathways the hedgehogs need to survive

In July 2019 the Government Communities Secretary added a condition to planning guidelines recommending Hedgehog Highways for new housing estates with small holes in the fences to come as standard. The holes need only be 13cm square ( the size of a CD case ). Already fencing manufacturers have made these modified fences available to the public for new fencing projects or to retro fit into boundaries.

# **CENSUS 2021**

Did you know the next census is due on 21<sup>st</sup> March 2021? Census Engagement Managers will work to maximize completion of the census, ideally online, across the area. Although households were able to complete the census online in 2011, take up was relatively low and most were returned in paper form. This census is Digital-First and it is hoped that three quarters of them will be completed online, though there will still be a paper option for those unable or unwilling to do so, as well as considerable support for anyone who needs help.

# UNAUTHORISED DEVELOPMENT OF FOWLERS STONE WOOD, HARVEL ROAD

Gravesham Borough Council were sucessful in obtaining a High Court Injuction with regard to the unauthorised development of Fowlers Stone Wood. Unfortunately the Land Owner continues to ignore the orders given in the injunction, and as such Gravesham Borough Council continue to gather evidence for their Legal Team to consider further action.

We have recently installed bollards along Waterlow Road, to deter Country Park visitors from parking on the Parish side of the road. No Parking signs will be installed on the bollards over the next few weeks.

PARKING

Kent Highways are working hard to ensure that our drainage systems are fully functioning and clear. It is frustrating to see so many leaves fall into the gutter, and we are grateful to Gravesham Borough Council for continuing to road sweep on a regular basis. However, we would ask all residents to avoid blowing or sweeping leaves into the gutters under any circumstances. This will only serve to block the drains.

The Bus Shelter in Erskine Road (at the time of writing this newsletter) had begun to have the panels replaced, and already is looking so much improved. Hopefully by the New Year all panels will have been replaced. This has been funded party by the Parish Council, and partly by a grant received from Kent County Council.

### Cold weather warning - Kent urged to keep warm and well

With cold and wintry weather predicted and Covid-19 social distancing restrictions in place, families across Kent are being urged to follow a few simple measures to keep their loved ones safe and healthy.

Prolonged cold weather can be a risk for anyone although vulnerable people, including the elderly and those with long-term medical conditions, are particularly at risk which creates further health concerns this winter season as Covid-19 cases are still prevalent in the community and those in vulnerable groups can be most at risk of severe symptoms

Simple tips such as making regular hot drinks and wearing several thin layers of clothes rather than one thick one can help to keep your body warm.

#### At home:

- Regular hot meals and drinks can help keep your body warm.
- Keep your home heated set the heating to the right temperature (18-21C).

• If trying to save fuel, it is advisable to heat the living room during the day, the bathroom when needed and the bedroom, just before going to bed.

• Get the flu vaccine to protect yourself and others. This is free for anyone over 65, pregnant women, those with long term conditions, and children aged two to four. Details are available at GP surgeries or pharmacies and the vaccine is free for some people.

• Order repeat prescriptions in good time to make sure you have enough supply of any medicines you use.

• Have your heating and cooking appliances checked regularly and make sure the chimney has been swept recently.

#### If you need to go out:

• Wear shoes with slip resistant, good grip soles.

• Make sure you are not caught out by snow and ice; stay tuned to the weather forecast and plan ahead with food supplies.

# COVENANT SURVEY RESPONSE SUMMARY, AND PROPOSALS TO VIGO PARISH COUNCIL

 IT IS IMPORTANT TO RETAIN THE OPEN PLAN DESIGN OF THE VILLAGE (303 responses)

Vigo Parish Council agreed that:

(i) That the Covenant regarding the open plan nature of the village is strongly enforced, and the rolling programme to deal with historical breaches of this covenant be continued.

(ii) In exceptional circumstances (to be discussed and agreed with VPC) low barriers may be permitted in between neighbours in detached properties. Where barriers are permitted, they must be either be at least 50% open OR if continuous less than 0.5 metres high. REMINDER: No barriers can be erected without prior approval from VPC.

# Vigo Parish Council agreed that:

Residents should maintain their rear and side garden fences at a maximum height of 1.8 metres, and at a minimum distance of 1.0 metre from any adjacent public footpath (permission to be sought before moving any fence). Low level planting (maximum height 0.9 metre) to fill the 1.0 metre gap MAY be permitted in exceptional circumstances, but approval needs to be given by VPC in advance.

Only clear glass windows will to be approved (no leaded lights, or Georgian style windows). Privacy glass will be permitted where appropriate.

Detached properties must be in keeping with the area, but VPC have discretion to approve a finish that does not exactly match the original. Radical changes will not be approved under any circumstances. If a detached property ever needed to be rebuilt, the new build should be in keeping with the rest of the street. Attached properties needing to be rebuilt should match the neighbours.
