#### June 2019 Floods - Update

Following the floods in Vigo last year, Kent County Council have published the Flood Investigation Report, which can be seen online via the following link:

Vigo Parish Council first received a draft of the report in April and have spent some considerable time since then making comments on the draft and asking for more extensive information to be included within the report. VPC are pleased to see that this has resulted in a fuller, more detailed report which clearly gives information on drainage repairs and cleansing work that has been carried out since last year.

Kent Highways have started an extensive program of drainage work in Vigo. Details of this are noted in the Flood Report and can also be found on our Facebook site and our website.

If you would like a copy of the KCC Flood Report, and are unable to view it online, please contact the Clerk who will supply a paper copy.

Residents are encouraged to report blocked drains to either KCC direct or to the VPC Clerk.

#### UNAUTHORISED DEVELOPMENT OF FOWLERS STONE WOOD, HARVEL ROAD

We are sure that everyone in Vigo, and the surrounding areas, are aware of the unauthorised development of Fowlers Stone Wood in Harvel Road. Soon after the land was sold, machinery moved in and a significant number of protected trees were felled. A large area of land was quickly cleared, and as a result of this a "stop notice" and then a temporary High Court Injuction was served on the owner.

The Parish Council continue to liaise closely with Gravesham Borough Council's Planning Enforcement Department, who have worked tirelessly on this case.

A date has been set for a further one-day hearing at the High Court, and a statement will be issued shortly after the hearing.

### WATERLOW ROAD PARKING - TROSLEY COUNTRY PARK



In the latter part of April this year, Government restrictions were lifted, meaning people were not restricted to exercising in their local vicinity. People were permitted to drive to an area outside of where they lived, as long as their drive was shorter than their hour's exercise. This resulted in a massive increase in parking on Waterlow Road when people visited the Country Park, especially as the car park was closed.

When the car parks were opened (in May) the situation eased slightly, but there were still great numbers of cars on Waterlow Road, causing issues for local residents. It is worth noting that the car parks in the Country Park were still often full.

Vigo Parish Council recently met with Cllr Bryan Sweetland (KCC Member), Cllr Ejaz Aslam & Cllr Denise Tiran (GBC Members) and Officers from Kent County Council and Trosley Country Park, to discuss these issues. A solution was agreed, and as a result bollards are likely to be installed on the Parish owned side of Waterlow Road, from the junction of The Coach Drive, down to the just before the "S" bend. We are also hopeful that Trosley Country Park will also ensure that when events are held in the park, marshals will be appointed to ensure that if parking overflows to outside of the country park, that this is done in a sensible and safe manner.



# **FLY TIPPING AND WASTE REMOVAL**

We would kindly remind residents that it is their responsibility to ensure that any waste disposal company (or individual) you engage to remove waste from your property must have the relevant waste carrier licenses.

You are perfectly entitled to request a copy of this, to ensure that the company you engage are a reputable firm, and as such they should be happy to provide the information to you.

#### ERSKINE ROAD BUS SHELTER

We are pleased to report that we have been successful in obtaining some grant funding that will pay for 50% of the cost of replacing all the panels in the Erskine Road bus shelter. This will tidy up the area significantly. We are hopeful that this work will be carried out over the winter period.

#### **PUBLIC ACCESS DEFIBRILLATORS**

You may have noticed that there are two new defibrillators in Vigo to complement the others which we already had. These have all been jointly provided by the Parish Council and the ambulance service.

A card detailing the locations is enclosed with this newsletter. Please keep this information safe. Copies of the card are available from the Parish Council.

The defibrillators have been put in locations that ensure everyone should be able to retrieve a defibrillator in less than 5 minutes. Much faster than a typical ambulance response.



We have provided the devices as the ambulance response to the village cannot be expected in less than 10 minutes. For every minute a person is in cardiac arrest without resuscitation, their chance of survival goes down by 10%. Where CPR and defibrillation is provided, the survival rate can be as high as 70%.

The code is available when you call 999 for an ambulance. The residents who have very kindly allowed placement of the devices on their property also know the code. Codes are also noted on the location card that we have enclosed with this newsletter. If you see someone tampering with a cabinet, please challenge them.

Free of charge training sessions will be held in the village hall in due course. Cllr Dave Hawkins will be running these, they will be informal and practical and will last around two hours. These courses will be advertised in due course (but we are afraid they will be delayed due to Covid restrictions for some time).

You do not need training to use the defibrillators, simply open the case and follow the instructions. You cannot harm someone with these devices, and they will not shock someone who doesn't need to be shocked! Please be advised that CPR is more important than the defibrillator, but if there is more than one person present at a cardiac arrest, a second person should collect a defibrillator.

#### What to do if someone suffers a collapse/cardiac arrest... In all cases dial 999

The ambulance service may ask if you can collect the defibrillator. They should advise on the nearest device. They will also coach you through delivering CPR. They may ask someone who has agreed to help to bring the defibrillator to you. They will provide the code.

An ambulance will be sent as soon as possible, however, in cardiac arrest, the initial actions are the actions which determine survival. Recognition, CPR and Defibrillation can all be provided without an ambulance being on scene and are lifesaving.

It is also worth considering retrieving the device if someone is experiencing chest pain and appears unwell with it (Vomiting, Shortness of Breath, Sweating, Grey or Pale)

You can help your family's chances of survival by having a plan to retrieve the defibrillator, knowing your closest one, and knowing CPR.

Please reach out to the Parish Council with any questions or comments, but we hope you will agree that these devices are a great addition to the community, any may help save a life.
